THE FOUNDATION HOSTS AND ORGANIZES A GOLF TOURNAMENT IN APRIL EVERY YEAR TO RAISE FUNDS TO DONATE TO THE USAFA ENDOWMENT FUND. FOR THE YEAR ENDED 4-30-18, 80 PEOPLE ATTENDED THE GOLF TOURNAMENT AND THE EVENT RAISED RAISED \$12,000 ALL OF WHICH WILL BE DONATED IN THE NEXT FISCAL YEAR. THE \$11,000 THAT WAS DONATED THIS YEAR WAS RAISED BY THE GOLF TOURNAMENT IN THE PREVIOUS YEAR. THE OBJECTIVE OF THE ORGANIZATION IS TO FOSTER THE PROFESSIONAL, BUSINESS AND LEADERSHIP GROWTH OF ITS MEMBERS THROUGH EDUCATION AND PROGRAMS. THE ANNUAL GOLF TOURNAMENT IS THE ACTIVITY THAT ALLOWS THE ORGANIZATION TO PROVIDE SUPPORT AND EDUCATION TO ITS MEMBERS, WHILE RAISING FUNDS TO SUPPORT CHARITABLE GIVING. THE AVERAGE DEDUCTION THAT PARTICIPANTS IN THE GOLF TOURNAMENT COULD CLAIM WAS \$62.35.

THE FOUNDATION ALSO HELD A MEMORIAL CEREMONY IN MAY WITH 40 PEOPLE ATTENDING, A NATIONALS BASEBALL GAME IN SEPTEMBER WHICH HAD 22 PEOPLE ATTENDING, AN AUGUST DINNER MEETING WHICH HAD 40 PEOPLE PRESENT, TWO CORPORATE NETWORKING EVENTS WITH BETWEEN 85-100 PEOPLE ATTENDING, AND THE ANNUAL FOUNDER'S DAY DINNER IN APRIL WHICH HAD 150 PEOPLE IN ATTENDANCE. DUE TO THE PROXIMITY OF THE FOUNDER'S DAY DINNER AND GOLF TOURNAMENT TO THE END OF THE FOUNDATION'S FISCAL YEAR, EXPENSES AND INCOME FROM THE EVENTS ARE NOT ALWAYS RECOGNIZED IN THE SAME FISCAL YEAR IN WHICH THE EVENTS TAKE PLACE.
